CALL TO ORDER: Kendall called the Meeting of the Ashland Electric Commission to

MINUTES: Dan Vaughn made a motion to approve the Minutes of May 22, 2012

as presented. Motion was seconded by Bobbi Hoerter. Vote was

unanimous.

OTHER BUSINESS: The Electric Commissioners asked the Water/Sewer Commissioners

to attend this meeting to discuss reading meters. Lee Nichols advised the boards that the Electric Department has hired two new employees and once they are trained they will take over the meter reading as of

October 1, 2012. Lee felt that a charge of \$.38 cents per meter

approximately \$2280.00 per year would now be a fair charge to read water meters. The Water/Sewer Commissioners will discuss this proposal at their next meeting on June 21, 2012 and have an answer

then.

OLD BUSINESS:

Ossipee Mountain Electronics assessed the radios on June 5, 2012 and will get pricing information back to Lee. They stated all radios will need to be digital by 2018. They are working on prices for both

analogue and digital.

NEW BUSINESS:

Lee advised the Commissioners he counted the new lights incorrectly and needs to add 9 more lights with lens covers to the original amount ordered. Dan Vaughn made a motion to approve the additional 9 lights with lens covers to be purchased from Bill Wentzell. Kendall seconded the motion. Vote was unanimous.

Lee is currently checking into lease/purchase price of a new Bucket Truck from C.U.E.S. and Kiley Inc.

Lee will attend the meeting on June 14, 2012 with Bethann McCarthy from Gomez & Sullivan Engineering and the Department of Environmental Services. They will discuss the FERC Safety Program for Squam Lake Dam.

Dan Vaughn made a motion to pay the Engineering firm of Gomez & Sullivan Engineering twenty three hundred dollars (\$2300.00) to coordinate with the State of New Hampshire on the Safety Program for Squam Lake Dam. Motion was seconded by Bobbi Hoerter. Vote was unanimous.
