# DRAFT MEETING MINUTES October 23, 2017 6:30 pm Ashland Fire Station

### **Committee Members Present:**

Meeting called to order at 6:34 pm.

<u>Minutes: September 19, 2017:</u> Fran motioned to accept as written; Steve seconded; All in favor.

**Update on PSU Contact**: Susan shared the responses from three PSU professors interested in projects on the list sent to Ben Amsden (Center for Business and Community Partnerships). Amy Villamagna who teaches the Sustainable Communities course highlighted several projects that potentially work for her students: For Town Administrator, assisting in the administration of the TAP grant and pursuing other related funding; Ms. Villamagna also has NHDOT funding for bikeability/walkability assessments for all of NH and expressed willingness to work on TAP grant and applying for further grants. For Planning Board, creating and conducting survey for the Master Plan update. For DPW, surveying invasive species locations and developing a best practices management plan. For P&R Department, work on researching and applying for grants, and work on a beach improvement project. For AEDC, assist in coordinating a charrette on the mill area, and on follow-up work on grants and public outreach educational materials. For the Conservation Commission, assist in researching information for updating the Master Plan chapter, and developing outreach projects and educational materials for public participation in conservation efforts in Ashland. Howard Frederick, Professor of Entrepreneurship is interested in speaking with us about our work in Ashland and how his project-based classes may play into our projects. The Committee felt we should invite him to a future meeting, and/or the summit in November. Chantalle Forgues is Assistant Professor of Business Law and was interested in our potential project of becoming a separate nonprofit redevelopment organization.

<u>Meeting with Anne Denton Cooley</u>: Miscommunication on a meeting led to her showing up for meeting in Ashland committee members didn't know was confirmed. She and Beno did meet up, and Fran will see her tomorrow (Oct. 24) at the Grafton County ED Council meeting in Plymouth. Another meeting will be arranged in the future.
