OLD BUSINESS:

Steve received another quote for the installation of electric in the new building. The quote was \$10,300.00 and did not include LED Lights. The previous quote was \$9000.00 and included LED Lights. One electrician could not do the job at this time and did not offer a quote.

Discussion regarding the bill we received from VPPSA. The bill received was incorrect and VPPSA will send a corrected bill with no penalties because the mistake on the bill was theirs. Steve would like to discuss not continuing to estimate the New Hampton bill going forward.

Steve checked into getting Verizon phones. 2 New phones for \$185.00 plus tax for unlimited talk, text & data. Included in the purchase is 1 new phone and Steve will have to check on a promo deal. Steve talked to Craig at Ossipee Mtn. Electronics and he could get a waiver from Steve Heath and Tony Randall to get a permit from Lakes Region, or he could contact Plymouth PD to see if he could get their permission.

NEW BUSINESS:

The floor in the Garage Bay needs to be repaired. Steve will get in touch with someone to get pricing for the repair.

Steve attended a meeting at the Water & Sewer Dept. with the contractor who will be putting in the new sewer receiving building. We will need to set a new pole just inside the fence and they will need a 3 phase transformer 150 KVA Padmount. The cost should be between \$1500. to \$3000. and will be our expense.

Steve made up a form to give customers when an outage is going to be scheduled. We will give 24 hour notice whenever the power would be shut down. He will be giving out several notices when they change out the transformers at the new Duplex on Mill Street.

We can possibly upgrade to fiber optics. Steve will call them to see if we can get a free router. Karen needs to hardwire into the router to run the new program. The handheld readers will improve reading times. Karen hopes to have the new billing ready for the April 1st billing and we can see about the handheld then. It will improve the reading time by 1/2 to 1 full day.

Discussion regarding Business vs Residential services will be on a case by case basis for General Service to determine where the cutoff will be.

Jamie made a motion to post the Lineman 1 position in house. Sandra seconded the motion. Vote was unanimous.
