UTILITY PARTNERS: The Utility Partners monthly update report was tabled for this meeting. It will be reviewed at a future meeting.

NEW BUSINESS: Eli Badger and Alan Cilley met with Tom Schwartz on Wednesday, June 13, 2018. The discussion revolved around two proposed 6' X 6' grit chamber designs: one with a standard valves and one with mud valves. Alan Cilley and Rusty Cross proposed a 12' X 12' chamber with doors. The new grit chamber would be installed just inside the gate to the plant.
