## PUBLIC WORKS

- T. Paquette asked for a raise due to the responsibilities that he has.
- S. Downing asked how many miles of roads are maintained. Answer was 20 miles.
- T. Paquette and his men are taking road scholar training. This is ongoing training. So he's asking for a little more to provide the opportunity for more training.

Under Director expense, misc testing, that is used for state random drug testing.

# **HIGHWAY & STREETS**

This part of the budget pertains to the highway garage.

Highway Equipment Maintenance is raised due to history.

Part of the Highway Summer Maintenance breakdown is as follows: roughly \$4,000. for catch basin cleaning, \$2,200. for street sweeping, \$7,200. for crack sealing (which was mainly up on Peppercorn).

Highway Uniforms includes a \$300. boot allowance per a previous warrant article.

Highway Fuel Paquette asked for \$30,000. Was revised to \$22,000. Paquette would like to see at least \$25,000.

Highway Equipment is for Digital Radios to be put in all trucks and equipment. They will need 9 mobile and one base, for \$10,000. Selectmen revised to \$6,000. to be able to get 5 mobile and one base this year, and the remainder to be asked for next year.

The 1981 bailer at the Transfer Station needs to be replaced. A new one, delivered and set up will cost approx. \$11,000. Another option is to get a used one for \$2,500. If the new bailer gets passed through by the voters, the company that sold us the used one for \$2,500. will buy the used one back for \$2,000.

Police training line needs to have \$1,800. taken out and put into Police supplies. This is for targets & ammo.
