They reduced \$35,000. for New Hampton power purchase. Increase coming in January.

PG. 2 & 3:

Acct # 311 (building maintenance) they want to put an overhang above entry door and put up an outside bulletin board.

Acct # 715 (power purchase) ISO charge to go up (transmitting charges)

Acct # 731.1 thru 732.5 has a 3% increase (greater Boston area plus 1%) (ISO)

Acct # 761.4 (engineering) is for a diagram of circuits (pole #, transformer #, where and what size fuses are in each). The last time that there was a diagram done was in 2006.

Acct # 732.3c (maintenance trees & right of way) will be overspent because

Acct # 761.2a (telephone) was increased.

Acct # 761.2b (postage) was decreased.

Acct # 761.3 (billing & accounting) includes Linda P. Karen, Kay and Linda G. salary.

Acct # 782.12 (computer expense) was decreased. They need new computers for the new billing system.

Acct. # 782.22 (life & disability insurance) was increased

Acct # 782.23 (workmen's comp) was increased

Acct # 782.5 (stores & shop) was increased (which includes fuses, toilet paper, ect.)

Acct # 797 (hydro maintenance expense) was decreased. The engineering is 25% done. We are rated as high hazard. We are trying to sub lease. FERC & engineering is Ashland electric responsibility. Maintenance is the state's responsibility.

Acct # 798 (depreciation) was increased by \$125,000.
