Salary and health insurance:

2011-2012 teachers pay 13% of the premiums

2010-2011 teachers paid 11% of the premium.

2% merit raise for non union employees. 11% premium pay for non union employees.

Medical insurance 7.6% maximum to be decided in May.

Dental decreased 4.3%.

Retirement increase: 11.3% teachers; 8.8% employees, good through summer 2013.

Medical deductable: Teacher pays \$500. district pays \$500.

We reviewed: Regular Education, Special Education, Extended school year, Bilingual, Co-curricular, Athletics, Attendance, Guidance Services, Health Services, Psychology, Speech Services, Physical & Occupational Therapy, Technology, Curriculum & Development, Library & Media Services, School Board Services, Audit Services, Legal Services, SAU Administration, Office of the Principal, Operation of Plant, Building & Equipment, Care of Grounds, Regular Transportation, SPED
