The Commissioners asked Lee to present this proposal to the Select board at their August 6, 2012 meeting.

Bobbi Hoerter made a motion to have Ossipee Mountain Electronics install the new radios & antenna per their quote dated July 20, 2012 at a cost of \$26,885.00 Dan seconded the motion. Vote was unanimous.

Dan made a motion to offer to pay the Department of Public Works (Highway) portion of the Ossippe Mountain Electronics quote dated July 20, 2012 in the amount of \$18,745.00, with a stipulation to repay Ashland Electric Department in full by May 1, 2013. Bobbi seconded the motion. Vote was unanimous.

Kendall talked to Lee about ordering wire for North Ashland Road and wanted to know about the tree trimming on North Ashland Road as well.

## **SUPERINTENDENTS REPORT:**

Discussion regarding department presentation at August 9<sup>th</sup> Budget Meeting. Alarm Company came in to check the alarm system because it keeps going off at various times. Need to get quote from TSI to test relays at the substation. Cell phones have been upgraded and the cost now should be about \$150.00 per month. The Commissioners have agreed to pay half of the cost of Devin's internet service and he will keep his own phone.
