**OLD BUSINESS:** A new telephone system being looked into by the Town was

Lee reported to the Commissioners that he has compared our rates with the Town of Wolfboro who has outsourced their Electric

Department. Our rates are currently 1 to 2 cents per kwh cheaper. 250 HPS Streetlights are \$36.53 ours are half that price.

Lee also met with Graybar regarding LED Streetlights. He reported that a 250 Watt High Pressure Sodium gives 11,607 Lumens while a LED gives 13,145 Lumens. The High Pressure Sodium uses 304 Watts while the LED uses 65% less. The major drawback would be the price of replacements.

## **NEW BUSINESS:**

The Streetlights turned off by the State on West Street and by the Interstate was discussed and Lee advised the Commissioners that complaints regarding a couple of near miss accidents came in from residents. Lee suggested several options the Commissioners could take, do nothing, turn on 4 lights or turn on all 11 and the Department would cover the cost.

Dan Vaughn made a motion to turn on 4 Lights out of the 11 turned off by the State and the Department will cover the cost. Bobbi seconded the motion. Vote was unanimous.

Dan requested that the Annual Report be written and placed in the Town Report this year. Financial reports were passed out for the Commissioners.
