The Electric Department Emergency Generator item from the last meeting was discussed. It was the consensus of the Board of Commissioners that the Generator would not be available for loan to Emergency Management at this time.

The Meet & Greet to be held at the Ashland Marina on September 22, 2015 was discussed. Businesses in Ashland area are being contacted and invited to attend.

NEW BUSINESS:

A new 70 Foot Flagpole located at the Ashland Ballpark was discussed. Lee Nichols would like to purchase a 70 Foot Pole and large Flag. Lights would be placed on the Booster Club and directed on the Flag. The 70 Ft. Pole can withstand 145 MPH winds and the flag can withstand 85 to 90 mph. The Commissioners decided to table this until the next meeting.

The Commissioners approved the hiring of Top Notch Tree Service & their 75 Foot Bucket Truck for more tree trimming around Ashland as needed.

Another \$25,000.00 was put into the Money Market Account to eventually pay off North Ashland Road Bond. This will bring the amount to date at \$200,431.73 Barring a catastrophic event this money will be used to pay off the bond early.
