MINUTES:

David Fucarile made a motion to approve the minutes of April 29, 2016 as presented. Sandra Coleman second. Vote was unanimous.

OLD BUSINESS:

Lee asked if Sandra had looked over the job descriptions. Sandra stated she had and also received a partial list from Linda Pack.

Lee asked Normand if it would be alright to bill the town at year end for the Mechanic Uniforms. He stated that would be fine.

Discussion regarding the amount of time required by the State for meetings to be posted. Mr. DeWolfe stated the time is 24 hours by State Law and that is what is followed by the Town. In the past the Electric Dept. followed 48 hours but will now follow the State Law of 24 hours.
