The Electric Department has hired a consultant to oversee the removal of the contaminated soil. His name is Jim Zeppieri of SRW Consultants. He has worked for the Department of Environmental Services previously and he feels confident it will be cleaned up by the end of the year. The plastic will be checked each day to make sure the contaminated soil is completely covered.

Lee stated that he did not know what the weight limit is on the Collins Street Bridge. He said approximately 500 tons of contaminated soil would need to be hauled out and the weight of the soil and trucks could pose a weight problem. He will check into this as soon as possible.
