MINUTES:

Motion was made by David Fucarile, seconded by Dan Vaughn to approve the Minutes of February 14, 2017 as presented. During discussion Sandra asked that an addition of: On Call Linemen must fill out the sign up sheet any time they wish to make a change to the on call schedule. Vote was unanimous.

OLD BUSINESS:

Both David and Sandra brought up the issue of Badges for Linemen to wear while they are out reading meters. Sandra will be providing the Badges.
