# Ashland Planning Board Amended Meeting Minutes Wednesday, July 11, 2018

<u>CALL TO ORDER:</u> Mardean Badger, Chair of the Ashland Planning Board, called the

meeting to order at 6:32 PM.

#### **DISPOSITION OF MINUTES**

The Planning Board reviewed the minutes from their Wednesday, June 27, 2018 meeting. Susan MacLeod made a motion to accept the minutes as amended. Leigh Sharps seconded the motion. The motion passed 3-0.

<u>Case #2018-05</u> Proposed Boundary Line Adjustment by EHFAR, LLC, to add part of T/M/L 021-002009-004 to T/M/L 021-002-009-003 and T/M/L 021-002-009-005, thereby eliminating T/M/L 021-002-009-004, located on Ridge Road, Squam River Landing, in the Rural Residential Zone.

### ACCEPTANCE OF APPLICATION

Leigh Sharps made a motion to accept the Site Plan application as complete. Susan MacLeod seconded the motion. The motion passed 3-0.

## **PUBLIC HEARING**

Mardean Badger opened the Public Hearing at 6:32 PM. She noted that the case had been duly noticed in the Laconia Daily Sun (June 28, 2018), posted at the Town Office and Post Office. All abutters were notified and return receipts were received. Matt Dickson, representing EHFAR, briefly explained the boundary line adjustments, which will result in 2 lots being expanded and 1 lot being eliminated. No abutters were present and the Board members had no questions.

Mardean Badger closed the Public Hearing.

Susan MacLeod made a motion to approve the boundary line adjustment by EHFAR, LLC, to add part of T/M/L 021-002-009-004 to T/M/L 021-002-009-003 and T/M/L 021-002-009-005, thereby eliminating T/M/L 021-002-009-004, located on Ridge Road, Squam River Landing, in the Rural Residential Zone. Leigh Sharps seconded the motion. The motion passed 3-0.

Concern was raised by Craig Moore (DPW) about the timeframe for the paving of Leavitt Hill Road. Matt Dickson stated that the paving project is scheduled by EHFAR to be completed in October. The contractor for the project has yet to be determined.
