## 1 TOWN OF ASHLAND 2 BOARD OF SELECTMEN MEETING MINUTES 3 **THURSDAY, MAY 6, 2021** 4 TOWN HALL 5 ASHLAND, NH 6 5:30 P.M. 7 CALL TO ORDER - Town of Ashland Chairman of the Board Eli Badger called the meeting 8 I. to order at 5:33 p.m. and requested a roll call of the Selectmen. Chairman Eli Badger and 9 Selectmen Ann Barney, Bob Letourneau, and Andy Fitch were present via the video conference. 10 Chairman Badger notified attendees that the meeting was occurring over video and 11 teleconference, a provision authorized by the Governor's Emergency Order #12 that waived the 12 physical presence of board members during the Covid-19 pandemic. 13 14 II. 15 **NEW BUSINESS** a. New Street Lights for Main Street - The Board discussed some of the new streetlights 16 for the Main Street TAP sidewalk project. Two new/upgraded crosswalks, one in front of 17 The Common Man restaurant and the other at the Booster Club, require that streetlights be 18 installed on either side of the street. The project plans call for standard wooden poles, 19 however, concerns about the appearance and visibility of these poles were raised. Craig 20 Moore presented options for more decorative lights that would look better but at a higher 21 cost. Ann Barney also expressed her concerns about the pole that has already been installed 22 at the Booster Club side of that crosswalk. It is large, unattractive and hinders visibility. 23 The more decorative poles will cost more than the standard wooden poles, but Craig did not 24 have the exact costs at this point. He estimated the cost to be approximately \$3,200 to 25 \$6,000. The standard wooden poles are approximately \$800. These poles would not be 26 wired to the existing utility poles, but rather an electric conduit would be installed in the 27 ground at the base. The poles need to be at least 16 feet high. The Board discussed the 28 option of installing the conduit to be ready for the decorative poles and a decision about 29 which pole could be made once more cost information was available. Craig assured the 30 Board that there was enough money in the Electric Department budget under equipment to 31 32 cover the cost. 33 34 MOTION: Andy Fitch To install the conduit base and choose either standard or decorative poles once the cost is known. SECOND: Bob Letourneau DISCUSSION: Bob Letourneau and Ann Barney discussed amending the motion to make the choice only among the decorative options. The motion was not amended.
