SHORT FORM OF WARRANT

The State of New Hampshire

To the inhabitants of the Town of Ashland in the County of Grafton, in said State, qualified to vote in Town affairs:

You are hereby notified to meet in the Town Hall, in said Ashland, on Tuesday, the eleventh day of March next, at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.

2. To raise such sums of money as may be necessary to defray town charges for the ensuing year, and make appropriation of the same.

To see how much money the town will vote to raise and appropriate of the following articles:

3. Police Department.

4. Fire Department.

5. Highways and Bridges.

6. Concrete streets and sidewalks.

7. Town Library.

8. District Nurse Association.

9. Town Poor.

10. Memorial Day.

11. To see how much money the Town will vote to raise and appropriate for continuing the control of the White Pine Blister Rust.

12. To see if the Town will vote to appoint a Committee to investigate the feasibility of a town forest and make recommendations at the regular town meeting in March 1925.

13. To see how much money the Town will vote to raise and appropriate to purchase a Wagon Scale, to provide a place to install the same, to be used as a Town Scale as provided by State Law.

14. To see if the Town will vote to authorize the Superintendent of Water Works, the Selectmen or a suitable committee to buy land or acquire additional drainage and flowage rights, or to take other action for the protection and increase of the Town Water supply and to expend the water rent funds for these purposes.

15. To see if the Town will vote to authorize the Selectmen to pay for the bonding of the Town Officers.

16. To see if the Town will vote to authorize the Selectmen to sell a part of the land belonging to the Electric Light Department.

17. To see what action the Town will take to acquire more land for the Town Dump, or to pay for damage done to land adjoining it and to raise and appropriate money for the same.

18. To see how much the Town will vote to raise and appropriate to pay on the Town Debt.

19. To bring in your votes for the election of Delegates-at-Large, Alternate Delegates-at-Large, District Delegates, Alternate District Delegates, to the National Conventions of the Democratic and Republican parties, to be held for the purpose of nominating party candidates for President and Vice-President of

REPORT OF THE SUPERINTENDENT

To the School Board of Ashland Special School District:

I take pleasure in submitting my sixth annual report as Superintendent of the Schools in Ashland.

Program of Studies

The only important change in the program of studies for this year is the substitution of commercial geography and arithmetic for French in the junior high school curriculum. The change was made necessary by the difficulty and expense involved in providing special classes in French for the few tuition pupils who entered grade IX from the rural districts without the preparatory work in this subject as given in our local junior high grades.

Thrift

Thrift continues to be taught effectively in our schools through the banking system. The Ashland Savings Bank furnishes the necessary banking cards and material.

A double checking system is used which prevents errors remaining undetected.

Music

It was possible to secure a regular supervisor of music this year, and already pleasing results are being shown in all the grades. While this arrangement is always desirable, it is not always possible, but we shall hope to continue the present plan, or a similar one, in the future. The solution of the music problem in our schools seemingly will be found only in several towns cooperatively engaging a supervisor of music.

Promotions

Realizing that a few children in our schools can readily cover the required work in less than the regular twelve years, several promotions have been made during this school year of those pupils who seemed most ready for advancement. Promotion at a suitable time will assure to such a pupil no loss in subject matter and an immense gain from being associated with a group of pupils more nearly his equal in capacity.

Parent-Teacher Association

The Parent-Teacher Association continues its worth-while activities. The meetings this year have been well attended, and the programmes varied and interesting. A reception was given to the teachers in September; Dr. Bell, of Plymouth, spoke at the "Health" meeting in November; the October meeting was given over to athletics and playground activities; Deputy Commissioner, J. N. Pringle, spoke at the De-

ember meeting; a musicale, under the direction of Miss Edith Platt, was held in January; and in February the teaching staff entertained the association with a pleasing programme.

Plans are maturing for health activities the coming summer; clinics for bad teeth and diseased tonsils; a playground supervisor for the months when school is not in session. The noon lunches and milk provided at the school for under-weight children is backed by the association, and is one of the most important phases of its activities.

Athletics

Provision was made this year through a special appropriation of \$300.00 for athletics to be placed completely under the charge of the school authorities, by the official appointment of an athletic coach and physical director. Results have proven the merits of the change. Physical development exercises are a regular part of the school programme; opportunity is provided for all boys in grades VII to XII to practice basket ball under supervision; three class teams have been formed, and the high school team is given efficient coaching at regularly assigned periods. We trust the present appropriation will be continued.

The foregoing report of the Superintendent is hereby approved, and as required by law, we, herewith, enumerate amounts required for payment on outstanding notes and interest for the coming school year:

From the above it will be seen that in March, 1926, the last money will be raised and appropriated for the present debt on the high school building.

Considerable work will need to be done on the roof of the high school building as soon as the weather permits in the spring. The late fall rains revealed several bad leaks around the ventilating shafts and the walls. A thorough examination of the roof showed that these leaks were due to the flashings rather than to the roofing. The coping was found badly out of line due to the water seeping in between the bricks and freezing. An expert roofer was brought here to examine the defects and to give competent advice. It is the opinion of the school committee that the coping and chimneys should be taken down to the roof and rebuilt; and that copper flashings should be used throughout. This will ensure permanency, and prevent destruction of the main walls of the building by further seepage and freezing. A special appropriation of \$1,000.00 is asked for this purpose.
