Town Manager's Letter

To the Citizens of Ashland:

This is the eleventh Town report to be issued under the Selectmen-Manager form of government and my first report as your Town Manager.

The annual budget for 1960 has been presented to the Budget Committee. Please understand that no member of the Board of Selectmen or Budget Committee can halt the continuous rising cost of living, cost of services, or cost of consumer products. We will, therefore, experience an increase in our tax rate again this year, in spite of our best efforts.

We are recommending an increase in the General Government division to allow for a raise for the Town Manager, more money for Election and Registration because of the presidential election, and repairs to the Town Garage and Fire Station.

The requirement recommended for the Police and Fire Departments will decrease this year through the discontinuation of a Special officer on Sundays through the winter months and a decrease in the payroll account of the Fire Department.

The Highway division has a \$1,055. increase. This is necessary due to the depletion of supplies, an increase in labor costs and the general increase in cost of materials.

The Welfare division has an increase of \$1,000. for Old Age Assistance. This account is not handled by the Town and we have very little control over expenditures. The State decides the amount to be given to the individual recipients and bills the Town accordingly on a percentage basis.

The Public Service enterprises division will, as has been stated, come under a new accounting system according to State law. No revenue will be returned to the Town until the depreciation account has reached an amount established by the Public Utilities Commission.

The Capital Reserves for Fire and Highway Departments and Town Construction will not be requested this year in our desire to keep the tax rate as low as possible.

Bonded indebtedness and interest have been reduced by the transferring of the utility accounts to their respective departments.

Revaluation of the Town by "outside professional assessors" is urgently needed. However, no funds for this work have been requested because the Town will not be billed for the work done until next year or the year after.

The preceding is a brief summary of the recommendations. If you have any questions on the above, please do not hesitate to ask this office. Remember, this office was created to serve you.

Activities of 1959

Town Maintenance:

A program of applying asphalt to as many of the gravel roads as the appropriation would allow was started a few years ago and has been continued to date.

Resurfacing was completed on several streets in Town.

The bridge to Batchelder's was completely rebuilt this past fall.

The usual maintenance work was carried on with culvert replacements, cold patching, brush cutting and drainage work.

Water Department:

The most beneficial activity conducted by this department for the citizens was the installation of water meters in 21 commercial establishments. The purpose of installing these meters was to conserve water and they did just that.

The Town used to use an average of 240,000 gallons of water a day. Now with only a few meters installed, we are using approximately 132,500 gallons a day, a saving of more than 100,000 gallons a day. The installation of meters was a controversial issue. Now, however, we all can see the advantage metering has produced.

The Water Department put in 16 new services. Two entirely new, and 14 from galvanized to copper pipe.

Electric Department:

The work in this department during the past year consisted mainly of maintenance of the lines and replacement of transformers.

Our extensive tree trimming program has proven itself again this past year, with just one power failure due to falling trees.

Complete physical inventory. Installation of water meters.

Electric Department:

Complete physical inventory.

Meter replacement program.

Installation of demand meters.

New line from Old Plymouth Road to Chipping Plant line along railroad tracks.

State of New Hampshire

To the inhabitants of the Town of Ashland, in the County of Grafton in said State, qualified to vote in Town affairs:

You are hereby notified to meet at the High School Auditorium in said Ashland on Tuesday the 8th day of March next, at nine of the clock in the forenoon, to act upon the following subjects:

- 1. To choose all necessary officers for the year ensuing.
- 2. Shall the Provisions of Chapter 171A of the Revised Laws, relating to playing games of Beano be adopted in this Town. (According to State Law this Article will appear on the printed ballot).
- 3. Do you favor the continuation of the Town Manager Plan as now in force in this Town. (RSA 37:15. Petitioned by 10 legal voters). According to Law this Article will appear on the printed ballot.
- 4. To see if the Town will approve and adopt the special recommendations of the Budget Committee and vote to raise and appropriate the various sums contained in the report and located in the Budget.
- 5a. To see if the Town will vote to raise and appropriate a sum not to exceed \$18,000.00 for the purchase of new Highway equipment.
 - b. To see if the Town will authorize the Selectmen and Town Treasurer to borrow and pay up to \$18,000.00 on the credit of the Town, for the financing of the new Highway Equipment in 5a above, under a 4-year bond and term note issue, payable in 4 equal yearly installments, with interest not to exceed four and one-half per cent.

(Recommended by the Budget Committee)

- 6. To see if the Town will authorize the Selectmen and the Town Treasurer to borrow a sum or sums not exceeding in the aggregate \$100,000.00 in anticipation of collection of taxes for the current municipal year and to issue in the name and on the credit of the Town, negotiable notes therefore, said notes to be repaid during the current municipal year from taxes collected during the current municipal year.
- 7. To see if the Town will vote for revaluation of the entire Town by private firm or the State Tax Commission. (The cost for revaluation to be raised next year).
- 8. To see if the Town will vote to discontinue the so-called Old Holmes Road.
- 9. To see if the Town will authorize the Selectmen to sell Tax acquired property.
- 10. To transact any other business which may legally come before said meeting.

Gentlemen:

Submitted herewith is the report of the annual examination and audit of the accounts of the Town of Ashland for the fiscal year ended December 31, 1959, which was made by this Division in accordance with the vote of the Town. Exhibits as hereafter listed are included as part of the report.

SCOPE OF AUDIT

Included in the examination and audit were the accounts and records of the Board of Selectmen, Treasurer, Tax Collector, Town Clerk, Trustees of Trust Funds, Water and Electric Light Departments, Municipal Court and Library.

FINANCIAL STATEMENTS

Comparative Balance Sheets: December 31, 1958-December

31, 1959: (Exhibit A-1)

Comparative Balance Sheets as of December 31, 1958 and December 31, 1959, are presented in Exhibit A-1. As indicated therein, the Net Debt decreased by \$2,584.23 in 1959.

Analysis of Change in Financial Condition: (Exhibit A-2)

An analysis of the change in financial condition of the Town during the year is made in Exhibit A-2, with the factors which caused the change indicated therein. These were as follows:

Comparative Statements of Appropriations and Expenditures Estimated and Actual Revenues: (Exhibit A-3 & A-4)

Comparative statements of appropriations and expenditures, estimated and actual revenues for the fiscal year ended December 31, 1959, are presented in Exhibits A-3 and A-4. As indicated by the budget summary (Exhibit A-4) a net overdraft of appropriations of \$8,314.35, less a net revenue surplus of \$1,448.16, resulted in a net budget deficit of \$6,866.19.

Summary of Receipts and Expenditures: (Exhibit B-1)

A summary statement of receipts and expenditures for the fiscal year ended December 31, 1959, made up in accordance with the uniform classification of accounts, is included in Exhibit B-1. Proof of the Treasurer's balance as of December 31, 1959, is indicated in Exhibit B-2.

Statement of Indebtedness: (Exhibit H)

A statement of outstanding long term indebtedness as of December 31, 1959, showing annual debt service requirements, is contained in Exhibit H.

AUDIT PROCEDURE

The accounts and records of all town officials charged with the custody, receipt and disbursement of public funds were examined and audited. Vouchers and cancelled checks were compared with supporting invoices and payrolls as well as entries in the books of record. Receipts were checked by source insofar as possible and totals of receipts and expenditures verified. Book balances were verified by comparison with reconciled bank balances made from statements obtained from depository banks. Verification of uncollected taxes was made by mailing notices to delinquent taxpayers as indicated by the Collector's records. The amounts of uncollected and unredeemed taxes as indicated in this report are therefore subject to any changes which may be necessitated by the return of verification notices.

GENERAL COMMENTS

Current Surplus:

The current surplus (excess of total assets over current liabilities) decreased by \$10,272.90, from \$11,403.64 to \$1,130.74 in 1959, as shown herewith:

Town Treasurer's Surety Bond:

It is again recommended that the surety bond of the Town Treasurer be increased from \$5,000.00 to \$18,000.00, in order that the amount of the bond may be more commensurate with the amount of funds in the custody of the Treasurer.

The provisions of Chapter 184 of the Laws of 1955, require that this report of the summary of findings and recommendations (letter of transmittal) shall be published in the next annual report of the Town.

Forest Fire Warden's Report

PREVENTION IS EVERYBODY'S BUSINESS

The year 1959 was fortunate from a forest fire standpoint. New Hampshire had the best record in the nation. Fewer acres were burned, suppression costs were substantially reduced and damage to woodlands held to a minimum. The record resulted from a combination of favorable weather conditions, an alert warden service and a cooperating public.

Yet, despite all this, there still persists a disturbing note. 58%, or 6 out of every 10 fires in 1959 were caused by careless smokers and debris burners.

10%, or 1 out of every 9 fires was caused by children.

Careless, indifferent, thoughtless and independent minded individuals and failure of parents to properly supervise children and keep matches out of their reach, annually cause these unnecessary fires which cost large sums to extinguish and cause extensive damage. The elimination of these three causes of fire would radically change this picture.

The rules are simple—

- 1. Before burning, secure a permit from your local fire warden the law requires it.
- 2. Be sure to properly supervise your burning.
- Make certain your fire is DEAD OUT before leaving it.
- 4. Don't throw lighted matches, cigars and cigarettes from moving vehicles use your ash tray.
- 5. Don't burn at home Use your town dump and save yourself much possible difficulty, both personal and financial.

Minutes of March 20, 1959

School District Meeting, Ashland, N. H.

The meeting assembled at the School Gymnasium on March 20, 1959 at 7:30 in the evening and was called to order by Clerk Lillian M. Young, who declared the meeting open and proceeded to action under Article 1 for the election of a Moderator. Mrs. Kathyrn Hall was appointed Clerk Pro Tem.

Article 1. Thomas Pryor was elected as Moderator and sworn in by the clerk.

Article 2. Lillian M. Young was declared elected as clerk and was sworn.

Article 3. Max Weisberg was declared elected as treasurer by the moderator.

Article 4. Motion made by Dr. L. Rockwood that the School District of the Town of Ashland vote to build and equip a new nine room elementary building, seconded. Presentation of needs was made by members of the School Board. The moderator stated the vote would be by ballot, appointed tellers Harold Baker, John Bilodeau and Robert Rhodes; checkoff on Town checklist to be made by Max Weisberg, town checklist supervisor; and the balloting proceeded with the following results:

Yes - 113; No - 95; Spoiled - 2; Total cast 210 votes, and the

motion carried by plurality vote.

Article 5. For School Board member for 3 years on first ballot, tellers appointed were Bernard Avery, Willard Hiltz and John Smith, with the following results:

Merrick LaBrique had 49 votes, Howard Guyotte had 112 votes, John Smith had 1 vote, Bilodeau had 1 vote, and Howard Guyotte was declared elected. Total votes cast 163. Needed for a choice 82.

For second School Board member for three years: Carlton Beard had 51 votes, William Norman had 57 votes, Robert Roby, June Baker and M. LaBrique each had one vote. Total cast 111. Needed for a choice, 57, Mr. William Norman had a majority and was declared elected.

For School Board member for 1 year: Bernard Paquette had 17 votes, Carlton Beard had 26 votes, D. Norman had 1 vote, Jeanette Lee had 48 votes. Total cast 92. Needed for a choice, 47. Jeanette Lee had a majority and declared elected.

Article 6. Voted to dismiss the article.

Article 7. Voted to accept reports as contained in School Report.

Article 8. Voted to raise and appropriate the sum of \$125,586.66 for the support of schools, for the salaries of school district officials and agents, and for the payment of statutory obligations of the district, and to authorize the application against said appropriation of such sums as are estimated to be received from the State Foundation Aid Fund together with other income; the School Board to certify to the selectmen the balance between the estimated revenue and the appropriation, which balance is to be raised by taxes by the town.

Article 9. Voted to accept the article as contained in in the warrant.

Article 10. Motion to adopt carried. Result of vote. For - 55, Against - 12.

Article 11. Motion carried to choose Agents, Auditors and Committees in relation to any subject embraced in this warrant, as necessary.

Article 12. Motion to adjourn carried.

Minutes of Special School Meeting April 28, 1959 — Ashland, N. H.

In accordance with the Warrant as published and legally warned, the meeting was called to order by moderator Thomas Pryor at 7:30 p.m. April 28, 1959 at the gymnasium.

The petition for Special School Meeting Warrant and request from the Budget Committee to the State Tax Commission were read, the business taken up as follows:

Article 1. Lawrence Rockwood made a motion that the Ashland School District vote to raise and appropriate a sum of one hundred and seven thousand dollars (\$177,000) for the construction of a new elementary school in accordance with the vote at the Annual School District Meeting, March 20, 1959, including architect's fees, furniture, furnishings, and equipment, and in order to provide such funds, to authorize the School Board to borrow the amount voted, and to issue serial notes or bonds, in the name and/or on the credit of the District, and to fix the time and place of payment, the rate of interest, terms, maturities, and provide for the sale thereof, all in accordance with the N. H. Revised Laws, Chapter 33, as amended known as the "Municipal Finance Act" and any amendments applicable thereto.

Allen K. Ober announced that the School Board had selected Mary Ruell to be spokesman for the School Board to show the necessity for more classrooms and why a nineroom elementary building would be more economical. Mrs. Ruell stated that she had discussed the water pollution problem with Senator Edward Bennett and it would be about seven years before it would go into effect and he thought pertinent school matters should come first. There being no further questions, moderator Thomas Pryor proceeded to explain the parlimentary procedure for voting. The polls were kept open until nine o'clock in the evening.

Acting upon a motion of Allen K. Ober, Helen R. May was elected clerk-pro-tem for the meeting. The clerk-pro-tem was then sworn in by the moderator.

Moderator Thomas Pryor appointed Howard Guyotte and Bernard Avery and John Bilodeau as tellers. The result of the balloting was as follows:

No - 190

On motion of Carlton Beard, seconded, "I move the School District of Ashland vote to raise and appropriate the sum of seventy-seven thousand dollars (\$77,000) for the construction of a four-room elementary school including architect's fees and furniture, furnishings and equipment, and in order to provide such funds to authorize the School Board to borrow the amount voted and to issue serial notes or bonds in the name of and on the credit of the District, and to fix the time and place of payment, the rate of interest, terms, maturities and provide for the sale thereof, all in accordance with Chapter 33, New Hampshire Revised Statutes Annotated (1955), known as the Municipal

Finance Act, and any amendments applicable thereto." The result was - total vote cast 136, necessary for a choice 91, Yeas 101, Nays 35, and the motion carried.

Action under Article 3. On motion of Albert Snow, "I move the Moderator be authorized to appoint a Building Committee consisting of 3 members to advise with the School Board in selecting a location for the new school, supervise the construction of said building, providing that the plans and specifications and selection of the site for the new school shall finally be approved, the School Board acting alone as required by law, and to further authorize the School Board to execute any and all contracts or agreements necessary in connection with the construction and equipping of said school." Submitted herewith is the report of the annual examination and audit of the accounts of the Ashland School District for the fiscal year ended June 30, 1959, which was made by this Division in accordance with the vote of the District. Exhibits as hereafter listed as part of the report.

SCOPE OF AUDIT

Included in the examination and audit were the accounts and records of the School Board and the School District Treasurer.

FINANCIAL STATEMENTS

Comparative Balance Sheets: (Exhibit A)

Comparative Balance Sheets as of June 30, 1958 and June 30, 1959, are presented in Exhibit A. As indicated therein the Net Debt decreased by \$5,059.77 during the fiscal year ended June 30, 1959.

Analysis of Change in Financial Condition: (Exhibit B)

An analysis of the change in financial condition of the School District during the fiscal year is made in Exhibit B, with the factors which caused the change indicated therein.

Comparative Statements of Appropriations and Expenditures - Estimated and Actual Revenues: (Exhibits C & D)

Comparative statements of appropriations and expenditures, estimated and actual revenues for the fiscal year ended June 30, 1959, are presented in Exhibits C and D. As indicated by the Budget Summary (Exhibit D), a net unexpended balance of appropriations of \$652.16, plus a revenue surplus of \$3,494.92, resulted in a net budget surplus of \$4,147.08.

Summary Statement of Receipts and Expenditures:

(Exhibit E)

A summary statement of receipts and expenditures for the fiscal year ended June 30, 1959, made up in accordance with the uniform classification of accounts, is included in Exhibit E. Proof of Treasurer's balance as of June 30, 1959, as indicated in Exhibit F.

Statement of Bonded Debt: (Exhibit H)

A statement of the outstanding long term indebtedness of the School District as of June 30, 1959, showing annual debt service requirements, is contained in Exhibit H.

Current Surplus:

It is noted that the current surplus (excess of total assets over current liabilities) decreased from \$8,252.30 to \$4,312.07, during the fiscal year ended June 30, 1959, as shown herewith:

Report of Superintendent of Schools

To the School Board and the Citizens of Ashland School District:

I respectfully submit my fifth annual report as your Superintendent of Schools.

As the American educational system has rapidly evolved, its goals have been variously defined as preparation for higher study, preparation for vocational endeavors, and preparation for life. At present, its whole philosophy can be summed up in two main concepts: the development of the individual to his optimum and the fostering of qualities needed for constructive citizenship.

These two basic concepts are really interlocking facets of the same fundamental attitude toward education, for only as each individual is helped to reach his potential can he be expected to make a vital and meaningful contribution as a member of the community. The democratic aspect of our educational system must not be thought of as a great levelling device which seeks to give each student exactly "equal" training, but rather a means of guaranteeing that each student be given the opportunity and the assistance to reach his own maximum fulfillment. Since pupils differ, this fulfillment will not only differ in kind but it will also be achieved through varying means.

Supervision and Instruction

As Superintendent, I feel our teaching staff is doing a commendable job in adjusting the program to the capacity and capability of the individual child, by stimulating the bright and alert pupils to do more, the average pupil to do his best, and recognizing the pupils who are less able than others. Each boy and girl is entitled to an education within his ability, and where this is made possible, we are bound to progress.

Supervisory Union #2 includes the school districts of of Ashland, Holderness, Inter-Lakes (Center Harbor-Meredith), Moultonboro and Sandwich, and there are many times when I realize that without the loyal support and efforts of the building principals and staff, that many of our accomplishments would not be possible.

Staff

We had only a few changes in the teaching staff this

year. Mrs. Ida Gammons retired from her teaching duties. Mrs. Frank Finley resigned as her husband had accepted a position in another section of the state. Mr. Thomas Coffey joined the staff at Franklin High. Mrs. Ivory Phillips accepted a position in her home town of Meredith. Mrs. Philip Morton, Jr., and Mrs. Franklin Wolf, are new members of the staff at the elementary school, and John Cote, Jr., replaced Mr. Coffey as science instructor. Mr. Irvin Wilkinson joined the staff as physical education and driver education instructor. Mr. Bruce Heald replaced Mr. Cowan as supervisor of music in the high school. Mr. Owen Moody, a former business education teacher, returned after serving two years in the Armed Services.

A small turn-over is a credit to the system and the citizens of Ashland. Happy teachers are effective teachers and the quality of education is directly related to the large number of competent teachers that continue to grow in our system. Thus, we are able to perpetuate a fundamentally sound philosophy of education.

Enrollment

The school year 1959-60 opened with an enrollment of 379 pupils. Grades 1 through 5 are in the elementary building and grades 6 through 12, in the high school. It was necessary to use the cafeteria as a classroom this year.

With plans well underway for the erection of a new four-room elementary building, we have made plans to assign grades 1 through 3 to that building, and to have grades 4 through 7 occupy rooms on the first and second floors of the present elementary building.

Building Maintenance

Mr. Leonard DuGuay is to be commended for the fine work he is doing in giving our children a clean and healthy atmosphere in which to work, and for protecting the district's investment in its school buildings and grounds.

Additions and Improvements

This past year a walk next to the gymnasium was constructed to permit better passage to the vocational building. The library-study was renovated and new shelves were placed along the wall space. This room is a very valuable part of the program, with the addition of a number of new reference books. New exit doors with safety panic devices were installed on the elementary building and two fire escapes were attached to the high school building, second floor. A new roof covering was placed on the high school.

Building Program

The construction of a four-room elementary school was authorized at the Special School District Meeting on October 14, 1959 and bids opened on Dec. 1, 1959. The bid of J. P. Leighton & Son of Center Harbor for the sum of \$72,105.00 was accepted with a starting date of April 1, 1960 and estimated completion date of August 15, 1960.

School Board

The community of Ashland was shocked to hear of the death of Allen K. Ober, Chairman of the Board, in December of 1959. Mr. Ober was serving his third term as a School Board member.

Transportation

Mr. and Mrs. Clarence Jordan are to be commended for doing an outstanding job of safe and efficient transportation of our pupils.

Conclusion

As executive officer of the School Board, and as spokesman and representative of the teaching and administrative staff, I wish to take this opportunity to express my sincere appreciation to the citizens of Ashland School Board, to all the school personnel, and to the citizens of Ashland for their cooperation and support this year.

The Superintendent's salary this year is \$8,500. The Supervisory Union's share is \$6,000. and the balance of \$2,500. is paid by the State.

Report of Principal

I am pleased to present to the people of Ashland my second annual report as the principal of your schools.

Curriculum:

Several additions have been made to the curriculum during the past year. These additions have given the youngsters in the Ashland schools expanded opportunity for learning at a time when increased knowledge is becoming a prerequisite for maintaining our position as a world leader. The subjects added this year were: Latin I, Economic geography, driver training and physical education. Chemistry and physics are now being taught each year, eliminating the possibility of a student missing either subject because of scheduling difficulties.

Physical Plant:

We are indeed thankful for the new four room elementary building that is to be constructed. This building will help alleviate the present overcrowded conditions in our high school building and will enable us to close off the hazardous third floor of the present elementary school.

The high school now has a new library of which we are very proud. New bookcases with adjustable shelves were constructed by Mr. Bartlett. The funds for purchasing the material for the bookcases, magazine rack, radiator covers, and paint for the room were raised through the sale of student pictures. New books are being purchased with funds raised by selling candy after school and during basketball games. The Ashland Fireman's Auxiliary gave a very generous donation for new books for the library. Another donation was received from the Ashland Junior Women's Club. In addition, many thoughtful people in town have given from their own libraries to aid the school in its quest for additional books. All of these gifts are greatly appreciated.

In addition to the library, several other changes have been made in the school plant. A new roof was put on the high school. The first floor of the elementary school was reinforced with beams and lally columns. Two sections of fire escapes were placed on the high school, one from the study hall on the second floor and one from the science laboratory. New panic locks were placed on the fire escape doors in the elementary building and the corridor of the high school was painted.

School Staff:

We have, at the present time an excellent staff in the Ashland Schools. Both new teachers and veteran teachers have contributed a great deal in giving our youngsters the type of education they need to become effective citizens of the community. In our endeavors we have all been aided greatly by the efficient medical, cafeteria, and custodial staff.

I would like to thank Mr. Heffernan, the School Board, the teaching staff and the pupils of the Ashland schools for their assistance in making this a most rewarding school year.

School Health Services

January 1, 1959 - January 1, 1960

The usual screening tests were done to find any symptoms of defects in hearing and vision.

Hearing tests were done in the spring and on pre-school children on registration day. The fall hearing tests were not done due to the Audiometer being sent for repairs.

Routine fall and spring heights and weights were done.

Physicals were done by Dr. Rockwood on grade 1, 2, 3, 4, 5, 6, 7, 9 and 11. Physicals were also given to those taking parts in sports.

Recommendations were made to improve all defects found, and notices were sent to parents.

Frequent inspections and home visits were made during the year.

The school nurse checked on all children that had been absent due to illness, before they entered class in a.m. Also checked at 1 p.m. The nurse is at school 8-9 a.m. and 1-3 p.m.

Tuberculosis patch tests were given and all that showed any reactions were checked by their family doctor, and had chest X-Rays.

Three immunization clinics were held in January, March and April.

In May we had a pre-school registration hearing tests done by the school nurse. Health information was recorded by the teachers. Mrs. Madeline Givens, State Dental Hygienist, was present to check their teeth and instruct mothers on the care of children's teeth.

This is a good opportunity for children and parents to acquaint themselves with the local school for children to enter grade 1 in September.

We had a Dental Clinic at school with Dr. Crowell from Plymouth. The Clinics were from 8:30 to 11:30 on Wednesdays. There were twenty-six clinic mornings and the children came for treatment by grades.
